INTEGR8 is a new project being developed by seven organisations across Europe with the aim of training migrant women to become champions of integration in their communities. The project will provide migrant women with the opportunity to develop skills and to build INTEGR8 their confidence so that they can in-turn empower others; helping other migrant women to

feel more accepted and integrated into the host communities, to access basic services and to learn

about their rights and entitlements in the host/ receiving countries.

Working in partnership with local migrant support agencies, education providers, migrant women's' networks and migrant women individually, project partners will develop a suite of training materials and will deliver this training locally between December 2016 and November



2018, when the project comes to an end. This training will be delivered through a series of practical workshops, networking and social events, and with the support of a dedicated online platform where trainees can access e-learning modules and integration resources.

#### **Professional orientation for vulnerable young people**

Eurostat (2015) estimated that almost 24 million people were unemployed in the EU-28, of whom over 18 million were in the Eurozone. Youth unemployment rate is more than twice higher than the adult one – 21.2 % against 9.8 %. More than 7,5 million young people across EU are neither in employment nor in education or training (NEETs).

The University of Nicosia participates in the 'Professional Orientation of Vulnerable Young People' project which seeks to promote reskilling and up-skilling across 8 Member States,

providing vulnerable young people with e-career guid-



ance. Moreover it aims to improve the orientation measures offered by the adult education providers in the field. In particular, it aims to reduce the number of low-skilled adults by providing career guidance using Open Educational Resources and offering tailored learning opportunities with particular emphasis on vulnerable young learners.

#### **Results of the interim evaluation of Horizon 2020**

The assessment of the first years of Horizon 2020 shows that it is on track to help create jobs and growth, tackle our biggest societal challenges and improve people's lives. Horizon 2020 has clear European added value by producing demonstrable benefits compared to national or regional-level support, but it has been so successful in attracting the best researchers and innovators that it could have spent

four times its budget in support of excellent projects. These are some of the main findings of the interim evaluation of Horizon 2020 published on the 29th of May 2017 by the European Commission.

The interim evaluation provides a comprehensive assessment of Horizon 2020 after its first three years. Of the first 11,000 projects funded so far, less than 10% have already finished (and their budget is less than 0.6% of the budget committed), so it is too early to talk about the final impact of Horizon 2020. However, the programme is already funding research and innovations that will make a difference to the economy and to people's lives.

Horizon 2020 demonstrates clear European added value in terms of economies of speed, scale and scope, pro-

ducing demonstrable benefits compared to national and regional-level support. 83% of projects funded would not have gone ahead without EU support.

The programme has proved extremely attractive and demand is high. Participants come from over 130 different countries and more than half are newcomers, meaning they did not take part in its predecessor, the 7th Framework Programme for Research (FP7). Annually, the number

of applications has increased by 65% compared to FP7, with 100,000 in total.

This leap in demand for European funding has, however, led to **oversubscription and a drop in success rates**, with some parts of the programme strongly underfunded. An additional EUR 60 billion would have been needed to support all the proposals that were scored "excellent" by independent evaluations.

Besides oversubscription, the evaluation also identified other areas for improvement, including stimulating and scaling-up breakthrough, market-creating innovation in particular by SMEs, and increasing the awareness and involvement of the general public in agenda -setting.

The European Union's investment into research and innovation for a greener and more efficient transport will follow a new strategy. The blueprint, entitled "Towards clean, connected and competitive mobility", is part of a "mobility package" adopted by the European Commission on the 31st of May 2017.

The document outlines short, medium and long term strategies for research and innovation in the transport sector, which correspond to rapidly changing needs. It identifies key areas of transport innovation, and the necessary actions to accelerate the development and deployment of innovative low-carbon technologies in transport. Since transport is a fast-moving and significant area, it requires close coordination and collaboration within and between the public and private spheres. A range of sectors, from industry and infrastructure to IT and telecoms, also have a role to play in exploring this new frontier.

The strategy focuses in particular on two main areas: automation and connectivity, and electrification of transport. These areas bring about disruptive innovation and significant opportunities for European industry and its competitiveness. They also hold great promise for reducing environmental impact of transport, in line with the Commission's comprehensive agenda for mobility as well as the Energy Union priority.

The document highlights the need to focus on users and citizens in shaping a transport research and innovation strategy, as well as to mobilise stakeholders across all sectors. It is also crucial that the EU provides roadmaps and establishes innovation-friendly conditions in order to maximise the impact of the investment into research and innovation. The EU's active involvement is also essential to overcome the many challenges – such as safety, public acceptance, cybersecurity, use of data, liability and ethical issues – that must be overcome before electrified, connected and automated transport becomes widely available.

#### Food-safety scientists wanted!

Are you a scientist with experience of food safety-related issues? Do you want to find solutions to food and feed safety challenges with scientists from other disciplines? Help the EU to protect the health and well-

being of European consumers, animals and the environment! On the 1st of June 2017, the European Food Safety Authority (EFSA) opened registration to experts to join its ten Scientific Panels and its Scientific Committee.

EFSA is an independent science-driven organisation working in the interest of European consumers, animals and the environment. Its motto is "Trusted science for safe food" and the knowledge, experience and decision-making of over 200 scientific experts are at the heart of its work. Their dedication makes it possible for EFSA to carry out its important mission. The scientific experts are at home in many fields: from toxicology, chemistry, microbiology, zoology, epidemiology and plant sciences to human medicine, veterinary medicine,

#### nutrition and ecology.

Experienced and independent scientists with the following basic requirements are invited to apply: a university degree and minimum seven years of profession-

al experience in a food-safety related scientific area. The scientists will be part of an international and interdisciplinary team contributing to food safety for millions of Europeans. Through EFSA's active international cooperation efforts their work will have global relevance. Working at EFSA puts them at a scientific hub in Europe and provides access to European and international scientific networks.

Every three years EFSA's ten Scientific Panels and its Scientific Committee renew their membership. The next renewal is in July 2018. The application procedure officially starts this year on 1 June and ends on 8 September 2017.

#### **European Health Award 2017 for NGOs Rewarding initiatives in the field of Vaccination**



The European Commission dedicates this year's EU Health Award to initiatives of nongovernmental organisations (NGOs) that contributed or are contributing to high standards of public health in the European Union through vaccination. The EU Health Award is funded under the 3rd Health Programme 2014-2020.

As with the EU Health Awards 2015 and 2016, this award is linked to the European Commission's work to build up a database of good practices in various health fields (Ebola in 2015 and AMR in 2016) from NGOs that can serve as models for the future.

The European Commission calls upon international, European, national and regional NGOs active in the field of vaccination to present details of their initiatives to the EU Health Award 2017. The call for applications targets initiatives that help achieving higher level of public health for Europeans through vaccination, with particular attention to several related aspects:

- Prevention: availability of vaccines and access to sustainable immunization services
- Awareness and information: promoting vaccination/advocacy
- Countering growing vaccine hesitancy
- Engaging with health care professionals to strengthen education/medical curricula/training, advocacy and health care professionals' communication skills
- Surveillance
- Tackling vaccination from a specific disease perspective (e.g. Human Papilloma virus HPV, seasonal flu, childhood immunisation, life-course vaccination/adult vaccination, synergies between vaccination and use of antibiotic).

The European drug market remains resilient, with some indicators for cannabis and stimulant drugs, in particular, now trending upwards stated the European Union's drugs agency at the launch of the "European Drug Report 2016: Trends and Developments".

In its annual review, the agency highlighted: the health risks of high-potency products, the continued emergence of new substances, and the changing patterns of drug use. It also expressed concern over rises in overdose deaths in some countries and the threats posed by internet drug markets.

#### Agriculture figures prominently in new framework for **EU-Africa relations**



A new strategic partnership between the EU and Africa was launched on May 4 with agriculture one of the main pillars of the new strategy. The agri-food sector is seen as a key area through which the EU can support rural and urban development in Africa.

According to a joint paper from the European Commission and the EU's High Representative for foreign affairs and security policy. Federica Mogherini, the EU will facilitate investments from the private sector in the African agri-food sector, building on initiatives such as the existing Agriculture Financing Instrument (AgriFI), in order to help boost jobs and address food security.

The plan also envisages enhancing vocational training and education in agriculture and the agrifood sector, in partnership with farmer organisations, as well as fostering research and innovation, building on the work of the existing Africa-EU roadmap on food and nutrition security and sustainable agriculture (FNSSA). The EU has in particular earmarked more than €4.2 billon for the 2014-2020 period for actions related to food and nutrition security and sustainable agriculture and fisheries.

#### **European Awards for Green Cities**

For the first time, in order to celebrate the 10th year of the European Green Capital competition, the Commission will award a financial incentive of €350,000 to the winning city of the 2020 European Green Capital title. A financial incentive of €75,000 will be awarded to the winner of the European Green Leaf 2019 title. The European Green Capital Award (EGCA), now in its 10th cycle, rewards cities for making positive change to improve their urban environments.



The European Green Leaf Award (EGLA), established in 2015, to commend the work of smaller cities in driving environmental change. Both Awards have a two-stage evaluation process. First, an international independent Expert Panel assesses each city's application, selecting a shortlist for the next stage of the competition. Applicants are assessed based on 12 environmental indicators, and EGLA applicants on six topic areas. Finalist cities then present to an international Jury, when they must show their ongoing commitment to improving their urban environments and their capacity to act as a role model to others. The deadline for submission of applications is 18 October 2017.

Following a thorough evaluation of the Birds and Habitats Directives, the European Commission has adopted the Action Plan for nature, people and the economy. The action plan is designed to improve implementation of the directives and thus boost their contribution to the attainment of the EU's biodiversity targets for 2020.

#### Strategy for high quality education

The Commission adopted on 30 May 2017 new initiatives on school and higher education, including a proposal on graduate tracking to help Member States collect information on what graduates do after their studies. The overall aim of these initiatives is to help Member States provide high quality and inclusive education for all young people through a series of concrete actions.

With regard to schools, evidence from Member States show three areas where action is needed and where EU support can help address important challenges:

- Developing better and more inclusive schools;
- Supporting excellent teachers and school leaders:
- Developing the governance of school education systems.

#### Promoting social inclusion through formal and non-formal learning



The European Commission has launched a public consultation on the "Recommendation on Promoting social inclusion and shared values through formal and non-formal learning". The online questionnaire will gauge public opinion on the importance of equipping young people with shared values and how education and non-formal learning can help achieve this aim in view of creating more socially cohesive societies. The public consultation will last until 11 August 2017.

In particular, the online questionnaire aims to gather input on the following questions: How successful are education and training in helping young people acquire shared values and promoting social inclusion? What are the key challenges?

What objectives should be pursued in this context? Which are the most effective policy approaches, tools and methods in formal and non-formal learning?

The Recommendation will establish a policy framework, as a key reference document at EU level to support Member States in providing education and training that promotes social inclusion and ownership of shared values while also contributing to preventing radicalisation leading to violent extremism.

#### New EU-Africa strategy: a major role for Erasmus+ and higher education cooperation



The European Commission's new Communication on a renewed impetus of the EU-Africa partnership, launched in May, has strong focus on education and youth. The new Communication link outside the EC domain sets out how the two continents can work together on common challenges, and in particular in the ways that Africa can deal with the impact of its rapid population growth and an increasingly young population. It is estimated that Sub-Saharan Africa needs to create 18 million new jobs each year up to 2035 to

absorb new labour market entrants, compared to the 3 million formal jobs created today.

This will need to unlock and unleash the full potential of young people. There is a clear role for education initiatives and Erasmus+. The Communication aims to launch new, or boost existing, initiatives including: more African participation in the Erasmus+ programme:

- mobility of staff and students and academic cooperation to improve students' skills and education quality and relevance;
- support to the harmonisation of higher education in Africa on the basis of experience gained in Europe;
- more focus on skills development with new pilot projects for VET mobility in Africa;
- developing the capacities of organisations that support young peoples' mobility and active participation in society;
- support for alumni networks and activities in Africa.

#### The main results of the newly released study are:

Awareness: There is a lack of awareness of FDL among migrants and refugees. The use of adequate communication channels such as social media or FDL tional funding, such "ambassadors" may increase awareness.

**Flexibility:** FDL allows migrants and refugees to start acquiring the skills they need for asking for asylum, a resident's permit, housing or to find employment, even before they arrive in the host country. The use of FDL in refugees' countries of origin and refugee camps has been identified as an opportunity.

Adaptation: Initiatives should adapt to learners' characteristics. The developers of FDL initiatives should take into account the fragility and diversity of migrant/ refugee target groups. Co-development with learners and cooperation with other initiatives and sharing of good practices can be helpful. Technology should also be adapted to the restrictions of the target groups (e.g. in some camps, internet connexion can be difficult).

Language learning: This is a first priority for the gen-



eral migrant and refugee community. Mobile apps could provide easily accessible first steps towards language learning and integration. Blending language training with other content acquisition enhances the efficacy of FDL initiatives.

**Recognition, quality assurance and accreditation:** FDL Higher Education initiatives should consider using Bologna tools (ECTS credits) and pursue recognition by European quality assurance agencies. Efforts should also be made to encourage employers to recognise FDL oriented to labour market skills.

**Sustainability:** FDL should not rely only on foundational funding, such as crowd-funding or grants. Diversification of funding, cooperation between initiatives, alternative income mechanisms and good communication channels to reach target group is needed.

Finally, the study identifies **two main research gaps** that need to be covered in order to continue improving the offer of FDL for migrants and refugees. **First, most FDL initiatives stem from the Higher Education sector** and little evidence is available about other migrant or refugee learning groups and their digital learning needs. **Secondly, the lack of specific (public) data on participation**, completion and impact makes it difficult to understand how refugees and migrants use FDL and the effects it has on their successful integration into society and labour market.

#### **Startup Europe Regions Network - SERN**



#### REGIONS NETWORK

High-growth firms are crucial for strengthening the European economy, and boosting innovation and competitiveness of European regions. They create many more new jobs compared to other firms. Several Member States have already put in place or are considering initiatives to create an environment conducive to innovation and entrepreneurship. At European level important initiatives have been taken to support startups. In particular on 22 November 2016, the European Commission launched the Startup and Scaleup initi-

ative as part of general strategy to make a deeper and fairer single market and help startups grow. Also, in partnership with the European Commission and since 2011, the Committee of Regions rewards every year EU regions which show an outstanding and innovative entrepreneurial policy strategy for the future.

However, further assessment is needed regarding the implementation of effective measures to support startups at regional level, notably reviewing progress made over time and promoting best regional practices.

In this context, the European Commission promoted the creation of **Start Up Europe Regions Network - SERN**, which was officially launched at a major event in October 2015 at the Committee of Regions. Since then, SERN has been set up as a non for profit organisation with a strong commitment to support startups and its activities, in particular by focussing on the mapping and promotion of support activities at regional level across Europe and by mobilizing regional resources to address relevant barriers to startups' growth, such as harmonization of regulations, access to talent and to major research infrastructures.

SERN aims at providing an annual overview and gauging of the measures taken by the regions to foster startup growth, highlighting best practices and showing cases studies. SERN will engage with the European institutions, local authorities and relevant stakeholders to ensure the success of this initiative.

Επείγουσες Καταστάσεις), στοχεύει στην ανάπτυξη ενός συστήματος λήψης και στήριξης των αποφάσεων, για να αντιμετωπίζονται άμεσα και επαρκώς, καταστάσεις μεγάλων φυσικών ή ανθρώπινων καταστροφών. Ο στόχος είναι η ανάπτυξη ενός συστήματος, το οποίο, με την βοήθεια καινοτόμων τεχνολογιών, θα επιτρέπει την ενδυνάμωση της ετοιμότητας και διαπεραστικότητας των ιατρικών υπηρεσιών, όχι μόνο κατά την διάρκεια των καταστροφών η των κρίσεων, άλλα και πριν και μετά από αυτές. Το σύστημα θα βελτιώνει επίσης τους μηχανισμούς διοίκησης και διαχείρισης κρίσεων και θα βοηθά αυτούς που λαμβάνουν αποφάσεις και ενεργούν, αξιοποιώντας πραγματικά ή προβλέψιμα δεδομένα και πληροφορίες. Το τελικό υποστηρικτικό σύστημα θα είναι ευέλικτο ως προς την προσαρμογή του σε διαφορετικά περιβάλλοντα και επείγουσες καταστάσεις και θα ενσωματώνει υπάρχουσες λειτουργικές τεχνικές και ιδιότητες, όσον αφορά την ασφάλεια και την εμπιστοσύνη στη χρήση των δεδομένων.

Αξίζει να αναφερθεί ότι το πρόγραμμα προκάλεσε το άμεσο ενδιαφέρον του Παγκόσμιου Οργανισμού Υγείας (ΠΟΥ), και υποσχέθηκε την έμπρακτη του στήριξη καθ' όλη τη διάρκεια υλοποίησης.

Η υλοποίηση του προγράμματος COncORDE πραγματοποιείται μέσω μιας ευρείας διεπιστημονικής συνεργασίας, με συμμετοχή επιστημόνων από 14 διαφορετικούς οργανισμούς από το Ηνωμένο Βασίλειο, την Ελλάδα, την Πορτογαλία, την Κύπρο, την Ολλανδία, τη Νορβηγία, την Τουρκία και το Βέλγιο. Η επιστημονική ομάδα του «Κοίος» έχει την ευθύνη καθοδήγησης του γενικού σχεδιασμού της αρχιτεκτονικής του συστήματος και επίσης θα συνδράμει σημαντικά στην ανάλυση των πραγματικών απαιτήσεων των τελικών χρηστών από ένα τέτοιο σύστημα, καθώς και στα στάδια δοκιμών και αξιολογήσεων του συστήματος.

Επικεφαλής της ερευνητικής ομάδας του «Κοίος» είναι οι Καθηγητές του Πανεπιστημίου Κύπρου, Μάριος Πολυκάρπου, Χρίστος Παναγιώτου και Γιώργος Έλληνας.
